Prospective tenderers shall meet at the Supply Chain Boardroom 5<sup>th</sup> Floor AS Chetty Building, at 10h00.** Only one Clarification Meeting will be held. An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. Tenderers who come after the stipulated starting time will not be allowed to be part of the meeting. No tender shall be accepted from tenderers who do not attend the above meeting.

Sealed tenders, endorsed on the envelope "**QUOTATION No. SCM Q91 OF 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00, on Monday, 08 April 2013**, when it will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**The Validity period** shall hold firm for ninety (90) days commencing from closing date of the tender.
