The Msunduzi Municipality hereby invites suitably experienced service providers to submit quotations for the above works. Only Tenderers who have a CIDB Grading of **1SO or Higher** and who are registered with the Institute of Plumbing South Africa (IOPSA) will be considered for appointment.

Quotation documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Tuesday**, **05 November 2013**. A non-refundable tender fee in the amount **R126.54** (Including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Site inspection meeting will be held at 10h00 on Friday, 08 November 2013. Prospective tenderers shall be required to meet on the date and time mentioned above at Berg & Retief Street Public Ablutions situated in corner of Berg Street and Retief Street, Pietermaritzburg. Only one Tender Briefing meeting will be held. *Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed quotation endorsed on the envelope "<u>SPECIALISED QUOTATION No. Q 73 OF 13/14</u>" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Wednesday**, **13 November 2013**, when it will be publicly opened. Only quotations placed in the Tender Box shall be accepted.

<u>The Validity period</u> shall hold firm for ninety (90) days commencing from closing date of the quotation.

<u>Tender Adjudication & Evaluation Criteria</u> will be implemented in line with the Msunduzi Municipality's approved Supply Chain and Preferential Procurement Policies on the **80/20** point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with **B-BBEE** as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000.

Each Service Provider will be informed of the quotation result.
