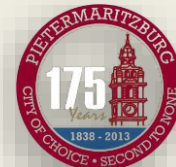

#### **APPOINTMENT OF CO-OPERATIVES OR SMMES TO PROVIDE DOMESTIC REFUSE COLLECTION IN PREVIOUSLY PHB HOUSING AREAS AND CURRENT INFORMAL AREAS FOR THE MSUNDUZI MUNICIPALITY**

The Msunduzi Municipality hereby invites the services of Co-Operatives (Co-ops) and in wards where no Co-op are, SMME's (Small Medium Micro Enterprises) will be considered to provide domestic refuse collection; using waste minimisation principles (recycling). Only service providers residing in the wards mentioned below will be considered.

Only cash or bank guaranteed cheques will be accepted.

**A compulsory Clarification Meeting will be held at 10:00 am at 10<sup>th</sup> Floor, Professor Nyembezi BLD, 341 Church Street, PMB, ON Friday 8<sup>th</sup> November 2013.** An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. **Tenderers who come after the stipulated starting time will not be allowed to be part of the meeting.** No tender shall be accepted from tenderers who do not attend the above meeting.

All tenders must be endorsed with the relevant Quotation No. and must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Road (Commercial Road), Pietermaritzburg, 3201, not later than **12h00, on Thursday, 14 November 2013**. Only tenders placed in the Tender Box shall be accepted where they will be opened in public and the totals, or sub-totals as the case may be, disclosed.

**The Validity period** shall hold firm for ninety (90) days commencing from closing date of the tender.

**Tender Adjudication & Evaluation Criteria:** The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. The Council does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender. Each Service Provider will be informed of the tender result. The Council expects businesses within the Pietermaritzburg and Midlands Region to support its contract and affirmative action programmes.
