Only one Representative per Company will be allowed to attend the meeting. No tender shall be accepted from Service Providers who do not attend the above meeting.

All tenders must be endorsed with the relevant Contract No. and placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Road (Commercial Road), Pietermaritzburg, 3201, not later than the closing dates and times mentioned above when they will be opened in public and the totals, or sub-totals as the case may be, disclosed. *Only Tenders Placed in the Tender Box Will Be Accepted and Considered.*

Tender Validity period: Three (3) months commencing from the closing date of the tender.

<u>Tender Adjudication/Evaluation Criteria</u>: The tender shall be evaluated on the 80/20 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
