

Invitation for Indigent Application for 2013/14 Financial Year

In terms of chapter 7 section 152 (b) of the constitution the municipality is mandated to provide basic services also to people that cannot afford to pay for such services in terms of universal access to basic services.

In order to fulfil this mandate orderly the municipality intends to update the indigent register , and therefore the municipality invites new and the renewal of existing applicants that are registered home owners that have value above R100,000 or the documented recipient of state funded social security pension

The intended beneficiaries will include:

- I. Old age pensioners;
- II. People living with disabilities on state grant;
- III. Child headed household and
- IV. Unemployed.

The following items must accompany the application:-

- i. The latest municipal account of the household together with:
- ii. Proof of the account holder's identity;
- iii. Proof of income of the account holder (e.g. a letter from his/her employer, salary slip/envelope, pension card, unemployment insurance fund (UIF) card, or a certificate to confirm registration as a job-seeker);
- iv. Proof of medical condition when requiring additional water and electricity above and above allocated quota.

Should the account holder be unable to apply in person, due to medical reasons, his/her application may be certified by a commissioner of oaths, preacher/pastor of church or a social worker.

The applicant must complete the sworn statement that forms part of the application form and Failure to do so will render the application invalid.
