Please note that this is a "**Two Envelope System**" request for proposals where Service Providers are required to submit their proposals in two clearly marked sealed envelopes, **Envelope One** for the "**Technical Proposal**", and **Envelope Two** for the "**Financial Proposal**", submitted on the tender documents provided by the Municipality incorporating additional proposal documents.

Sealed tenders must be endorsed on the envelopes with the relevant "Specialised Contract No. SCM 36/R of 12/13: Envelope One – Technical Proposal" and "Specialised Contract No. SCM 36/R of 12/13: Envelope Two – Financial Proposal", which must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, 3201, not later than 12h00, on Thursday 28 March 2013.
