TENDER NOTICE

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Contractors for the rehabilitation/replacement of defective sewerage reticulation: Phase 1. **Only tenderers with a CIDB Contractor grading of 6CEPE or higher, who have the relevant expertise, capacity, experience and/or construction equipment shall be eligible to submit tenders.**

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Tuesday 11 June 2013**. A non-refundable tender fee in the amount **R600.78** (including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A **compulsory Tender Briefing Meeting** will be held at **12h00** prompt on **Wednesday 19 June 2013**, in the **Water and Sanitation Boardroom, 3rd Floor, Professor Nyembezi Centre, 341 Church Street, Pietermaritzburg**. Only one Tender Briefing Meeting will be held. An official will chair the meeting and answer any queries raised by prospective tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. **No tender shall be accepted from tenderers who do not attend the above meeting.**

Sealed tenders in accordance with the Conditions of Tender and Tender Data and endorsed on the envelope **"Specialised Contract No. SCM 68 of 12/13"** must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Friday 28 June 2013**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Ninety (90) days commencing from the closing date of tender.

Tender Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System, Stage One being Functionality and Stage Two based on the 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-

2	Completion of waterborne sanitation infrastructure construction projects in built-up areas with a minimum contract value of R8m.	16 Points
3	Completion of infrastructure replacement projects using the pipe bursting trenchless method with a minimum length of pipe replaced per contract of 500m.	20 Points
4	Bank Rating.	10 Points
5	Contracts Manager: Years of relevant experience in civil engineering construction projects.	10 Points
6	Site Agent/Foreman: Years of relevant experience in civil engineering construction projects.	14 Points
7	Pipe Bursting Machine/Equipment Operator: Years of experience in utilising machine/equipment on projects.	14 Points
