REHABILITATION/REPLACEMENT OF DEFECTIVE SEWERAGE RETICULATION: PHASE 2

Tenders are hereby invited from suitably qualified and experienced Tenderers for the above works. The objective is to undertake the Replacement of Sewerage Reticulation primarily in Wards 33, 13 and 15 by a combination of conventional open cut excavation methods and pipe bursting trenchless technology methods to ensure that all existing 'old problematic' sewers are replaced and can provide maintenance free life for at least another 40 years.

Only tenderers with a CIDB Contractor grading of 6CEPE or higher, who have the relevant expertise, capacity, experience and/or construction equipment shall be eligible to submit tenders.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Monday 1 July 2013**. A non - refundable tender fee in the amount **R600.78** (including VAT) per document shall be levied. Only cash or bank quaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at 10h30 prompt on Tuesday, 9 July 2013, in the Water & Sanitation Boardroom, 5th Floor, Professor Nyembezi Building, 341 Church Street, Pietermaritzburg, 3201. Only one Tender Briefing meeting will be held. *Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders in accordance with the Conditions of Tender and Tender Data and endorsed on the envelope "Contract No. SCM 76 of 12/13" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than 12h00, on Friday 19 July 2013, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

<u>Tender Validity Period</u>: Ninety (90) days commencing from the closing date of tender.

<u>Tender Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. The Functionality for Stage 1 shall be as follows:-

5	Contracts Manager: Years of relevant experience in civil engineering construction contracts	Max 10
6	Site Agent/Foreman: Years of relevant experience in civil engineering construction projects	Max 14
7	Pipe Bursting Machine/Equipment Operator: Years of experience in utilising machine/equipment on projects	Max 14
