Tenders are hereby invited from suitably qualified and experienced Service Providers for the above works.

A non - refundable tender fee in the amount **R 360.24** (including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at **10h30 prompt on Wednesday**, **10 July 2013**, in the **Water & Sanitation Boardroom**, **5**th Floor, Professor Nyembezi Building, 341 Church Street, Pietermaritzburg, **3201**. Only one Tender Briefing meeting will be held. **Tenderers arriving at the meeting after the stipulated starting time will be disqualified.** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders in accordance with the Conditions of Tender and Tender Data and endorsed on the envelope "Contract No. SCM 73 of 12/13" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than 12h00, on Friday 19 July 2013, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Ninety (90) days commencing from the closing date of tender.

<u>Tender Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. The Functionality for Stage 1 shall be as follows:-

Only Tenderers who score a minimum of 80% and above in Stage 1 shall be considered for Stage 2.
