Only quotations placed in the Tender Box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the quotation.

<u>Tender Adjudication & Evaluation Criteria:</u> The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on **80/20** point system in accordance with the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000. Only Tenderers who score a minimum of 70% and above in Stage 1 shall be considered for Stage 2.

The Msunduzi Municipality does not bind itself to accept the lowest or any quotation and reserves the right to accept the whole or any part of a quotation. Each Service Provider will be informed of the quotation result.
