The Msunduzi Municipality hereby invites the services of Co-Operatives (Co-ops) to provide domestic refuse collection; using waste minimisation principles (recycling), where such are already not in operation, in the areas listed below. **A compulsory Tender Briefing Meeting will be held at 10h00 prompt on 31 January 2014, in the Auditorium, 10<sup>th</sup> Floor, Professor Nyembezi Building, 341 Church Street Pietermaritzburg.** An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***Only one (1) Representative per Company will be allowed to attend the meeting. Tenderers arriving after the stipulated starting time mentioned above will not be allowed to attend the meeting.*** No tender shall be accepted from tenderers who do not attend the above meeting.

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 32 (R) of 13/14**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, 3201, not later than **12h00 on Monday, 17 February 2014**. Only tenders placed in the tender box shall be accepted.

**The Validity period** shall hold firm for ninety (90) days commencing from the closing date of the tender.

**Tender Adjudication & Evaluation Criteria:** The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

The Council does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender. Each Service Provider will be informed of the tender result. The Council expects businesses within the Pietermaritzburg and Midlands Region to support its contract and affirmative action programmes.
