Only cash or bank guaranteed cheques will be accepted.

A compulsory tender briefing meeting will be held at 10h00 on Tuesday, 13 May 2014. Prospective tenderers shall be required to meet on the date and time mentioned above in the Supply Chain Management Boardroom, 5<sup>th</sup> Floor, A.S. Chetty Building, 333 Church Street, Pietermaritzburg, 3201. Thereafter proceed to site. Only one Tender Briefing meeting will be held. *Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. No tender shall be accepted from tenderers who do not attend the above meeting.

Sealed quotation endorsed on the envelope "<u>SPECIALISED QUOTATION No. Q 163 OF 13/14</u>" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Friday**, **16 May 2014**, when it will be publicly opened. Only quotations placed in the Tender Box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the quotation.

<u>Tender Adjudication & Evaluation Criteria</u> will be implemented in line with the Msunduzi Municipality approved Supply Chain and Preferential Procurement Policies on the **80/20** point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with **B-BBEE** as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000.
