Tender Validity Period: 4 Months from the closing date of tender.

Tender Adjudication and Evaluation Criteria: The tender shall be evaluated on the 80/20 or 90/10 Preference Points System (as the case may be) and in accordance with the Preferential Procurement Regulations 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The adjudication criteria will be as per the tender document.

Under no circumstances whatsoever will any extension of time be allowed for submission of tenders. The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result. The Msunduzi Municipality expects businesses within the Pietermaritzburg and Midlands Region to support its contract and BEE/SMME initiatives.
