**A compulsory Tender Briefing Meeting will be held at 10h00 prompt on Friday, 17 April 2015, at the Supply Chain Management Unit's Boardroom, 5<sup>th</sup> Floor, A S Chetty Building, 333 Church Street, Pietermaritzburg, from where all will travel in convoy to site.** Only one Site Inspection meeting will be held. An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***Tenderers arriving at the meeting after the stipulated starting time will not be allowed to attend the meeting. Tenderers must present their tender document at the meeting failing which the Tenderer shall be disqualified.***

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 92 of 14/15**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00, on Thursday, 23 April 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Ninety (90) days commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on the 80/20 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
