- (t) That to give proper effect to the Msunduzi Municipality's annual budget, cash-backing is implemented through the utilisation of a portion of the revenue generated from property rates to ensure that all capital reserves and provisions, unspent long term loans and unspent conditional grants are cash-backed as required in terms of the Msunduzi Municipality's Funding and Reserves Policy as prescribed by Section 8 of the Municipal Budget and Reporting Regulations.
