The Msunduzi Municipality hereby invites suitably experienced tenderers to submit quotations for the above works. Only Tenderers who have a CIDB grading of **1GB or higher and have completed at least three(3)** similar projects. Tenderers are also required to submit a construction programme for the execution of work. Tenderers will be evaluated according to the specification of the contract.

Quotation documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Monday**, **05 October 2015**. A non-refundable tender fee in the amount **R 141.36** (Including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

Prospective tenderers shall be required to meet at 09h00 on Wednesday, 14 October at Supply Chain Management offices, 5th floor, A.S Chetty Building, 33 Church Street, Pietermaritzburg, 3201. Thereafter proceed to site where a compulsory briefing meeting will be held in the Boardroom at Fire and Rescue Department at Old Edendale Road @09h45 on Wednesday, 14 October 2015. Only one Tender Briefing meeting will be held. Tenderers arriving at the meeting after the stipulated starting time will be disqualified.

Sealed quotation endorsed on the envelope "<u>SPECIALISED QUOTATION No. Q 72 OF 15/16</u>" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Monday**, **19 October 2015** when it will be publicly opened. Only quotations placed in the Tender Box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the quotation.

<u>Tender Adjudication & Evaluation Criteria</u> will be implemented in line with the Msunduzi Municipality's approved Supply Chain and Preferential Procurement Policies on the **80/20** point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with **B-BBEE** as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000.

Each Service Provider will be informed of the quotation result.
