APPOINTMENT OF A CONTRACTOR TO REPAIR THE ALEXANDRA PARK FOOT BRIDGE

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Contractors for the repair of the Alexandra Park Foot Bridge, Alexandra Park, Pietermaritzburg.

Only Contractors registered with the Construction Industry Development Board (CIDB) with a Contractor Grading of 2GB, or higher, shall be eligible to submit tenders.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Monday**, **02** November **2015**. A non - refundable tender fee in the amount **R169.86 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Clarification Meeting will be held prompt at 10h00 on Thursday, 05 November 2015, in the Exco Boardroom, 4th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from where all will travel in convoy to site. Only one Tender Clarification Meeting will be held. *Note: Tenderers arriving at the meeting after the stipulated starting time above will be disqualified*.

Sealed tenders endorsed on the envelope with "Contract No. SCM 27 of 15/16" and the relevant Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than 12h00 on Thursday, 19 November 2015, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Three (3) months commencing from the closing date of tender.

<u>Tender Adjudication/Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-

1	Number of Previous Projects – specifically in similar timber intensive related projects.	20 Points
2	Number of Years of Experience of a Qualified Carpenter – that will be deployed to undertake this project.	20 Points
3	Locality of Company	10 Points
Total Functionality Points		50 Points
Threshold		50% (25 Points)
