CONSTRUCTION OF APPROXIMATELY 800m SEWER RETICULATION PIPELINES AND 500m WATER PIPELINE AND HOUSE CONNECTIONS IN IMBALI UNIT 18 WARD 15

The Msunduzi Municipality hereby invites tenders for the above works. Only tenderers with a CIDB Contractor grading of 3CE or higher, who have the relevant expertise, capacity and experience, shall be eligible to submit tenders.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **14h30** on **Tuesday**, **2 February 2016**. A non-refundable tender fee in the amount **R425.22** (Inc. VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing/Site meeting will be held at **10h00 prompt** on **Friday**, **12 February 2016**, at the Imbali GEDI Offices, Corner of Sutherlands and F.J. Sithole Roads, Imbali. Only one compulsory Clarification/Site Meeting will be held. *Note: Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* No tender shall be accepted from tenderers who do not attend the above meeting. Tenderers will be required to present their tender document at the Clarification Meeting.

Sealed tenders endorsed on the envelope "<u>CONTRACT No. 30 OF 15/16</u>" with the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **Friday**, **19 February 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Ninety (90) days commencing from the closing date of tender.

Tender Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

Functionality for Stage 1 shall be as follows:-		Points Allocated
