# TENDER NOTICE

## **UPGRADING OF AND BEAUTIFICATION OF THWALA ROAD : EDENDALE**

#### This Tender Notice Supercedes the previous Tender Notice published on 17 March 2016.

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Contractors for the above work. Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **14h00** on **Thursday, 24 March 2016**. A non - refundable tender fee in the amount **R 425.22 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at 10h00 prompt on Thursday, 31 March 2016 at GEDI Offices, situated at the corner of F J Sithole Road & Sutherlands Road, Edendale, Pietermaritzburg, 3201, from where all will travel in convoy to site. Only one Tender Briefing meeting will be held. *Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. *Tenderers must present their tender document at the meeting failing which the Tenderer shall be disqualified.* Only one (1) Representative per Company or Joint Venture or Consortium will be allowed to attend the above meeting.

Sealed tenders endorsed on the envelope "<u>Contract No. SCM 44 of 15/16</u>" and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **Wednesday**, **13 April 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Three (3) months commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria**: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.

The Functionality for Stage One shall be evaluated on the following criteria:-
