APPOINTMENT OF A CONTRACTOR TO RELOCATE STEEL PIPELINES AROUND ORIBI AIRPORT, PIETERMARITZBURG

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Contractors to undertake the above works. **Only Contractors registered with the Construction Industry Development Board (CIDB) with a Contractor Grading of 7CE or higher, shall be eligible to submit tenders.**

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Tuesday, 31 May 2016**. A non - refundable tender fee in the amount **R707.94 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing Meeting chaired by the appointed Consulting Engineer will be held on **Friday, 10 June 2016**, in the **Water and Sanitation Boardroom, 3rd Floor, Professor Nyembezi Centre, 341 Church Street, Pietermaritzburg**, commencing promptly at **10h30**. Thereafter, all shall travel in convoy to site for a Site Inspection. Only one Tender Briefing Meeting and Site Inspection will be held. ***Tenderers arriving at the meeting after the stipulated starting time above will be disqualified. Further, all Tenderers attending the meeting must be in possession of a Tender Document, failing which the Tenderer shall be disqualified.***

Sealed tenders endorsed on the envelope with “**Specialised Contract No. SCM 52 of 15/16**” and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Monday, 27 June 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Three (3) months commencing from the closing date of tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-

3	Previous successful steel pipeline projects of similar nature (≥ 300mm Ø) with a minimum contract value of R5 million. Supporting documents with traceable references to be submitted.	20 Points
4	Locality of the Company	10 Points
Total Functionality Points		80 Points
Threshold to qualify for Stage Two		65 Points
