#### **APPOINTMENT OF A TRAINING SERVICE PROVIDER FOR GENERAL CONDITIONS OF CONTRACT (GCC) AND RULES AND REGULATIONS OF THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD (CIDB) 2015**

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Training Service Providers to undertake training on the General Conditions of Contract (GCC) and rules and regulations of the Construction Industry Development Board (CIDB) 2015.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Tuesday, 14 June 2016**. A non-refundable tender fee in the amount **R425.22 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

Sealed tenders endorsed on the envelope with “**Contract No. SCM 57 of 15/16**” and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Monday, 11 July 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Three (3) months commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tenders shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
