The Msunduzi Municipality hereby invites tenders for the above works for a three (3) year period as and when required. Only tenderers with a CIDB Contractor grading of 5EP or higher, who have the relevant expertise, capacity, experience and/or equipment, shall be eligible to submit tenders.

Only tenders placed in the Tender Box shall be accepted.

<u>Tender Validity Period</u>: Ninety (90) days commencing from the closing date of tender. <u>Tender Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
