CALL FOR PROPOSALS ON PLACEMENT AND MANAGEMENT OF INVESTMENTS FOR THE MSUNDUZI MUNICIPALITY

The Msunduzi Municipality hereby invites tenders from suitably approved Service Providers to establish a panel for the placement and management of municipal investments for a period of three (3) years.

Only Service Providers meeting the following requirements shall be eligible to submit tenders:-

- Proof of registration with the South African Reserve Bank (SARB),
- Proof of registration with the Financial Services Board (FSB) as an authorised financial Service Provider,
- Proof of an operating license with the Financial Services Board (FSB),
- Proof of registration with the National Credit Regulator (NCR), and
- References from at least three (3) Municipalities that the Service Provider has provided similar services to.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Wednesday**, **17 August 2016**. A non - refundable tender fee in the amount **R750.12 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

Sealed tenders endorsed on the envelope with "**Contract No. SCM 1 of 16/17**" and the relevant Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00** on **Friday**, **16 September 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Three (3) months commencing from the closing date of tender.

<u>Tender Adjudication/Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
