PANEL OF CONTRACTORS FOR THE CONSTRUCTION OF WATER AND SANITATION INFRASTRUCTURE PROJECTS

The Msunduzi Municipality (Water and Sanitation Unit) will be embarking on extensive grant funded Water and Sanitation construction projects, set to commence in this 2016/2017 financial year.

As a result, the Municipality hereby invites suitably qualified and experienced Contractors with a CIDB Contractor Grading of 2CE, or higher, to submit their qualifications and experience, as well as other information as required by the Municipality. Documents detailing these requirements may be obtained from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Monday, 24 October 2016**.

The above information, as well the Functionality Test hereunder, will be used to select suitably qualified and experienced Contractors who will be invited to participate in a closed tender process in terms of Clause 36 of the Municipality's Supply Chain Management Policy. Tenderers will be classified in terms of their CIDB Contractor Grading and only tenderers with the CIDB Contractor Grading corresponding to, or higher to, the one required for that specific project will be invited to participate in the closed tender process. The work, as far as practically as possible, will be distributed on a rotational basis in order to allow for an even distribution of the work.

Contractors will be required to submit together with their Curriculum Vitae the following information:-

- Proof of valid CIDB Contractor Grading.
- Original valid Tax Clearance Certificate or Tax Compliance Status Verification Pin as issued by SARS.
- Certified copy of VAT Registration Certificate (if VAT number is not included in Tax Clearance Certificate).
- CSD Supplier Number and Unique Registration Reference Number.
- Certified copy of a Workmen's Compensation Certificate, Act No. 4 of 2002.
- Certified copy of Unemployment Insurance Certificate, Act No. 4 of 2002.
- Certified copy of Certificate of Incorporation (if tenderer is a Company).
- Certified copy of Founding Statement (if tenderer is a Closed Corporation).
- Certified copy of Partnership Agreement (if tenderer is a Partnership).
- Certified copy of Identity Document (if tenderer is a one-man concern).
- Joint Venture Agreement (if tenderer is a Joint Venture).
- Curriculum Vitae of the person who prepares the Contractor's Health and Safety Plan.
- Curriculum Vitae of the Health and Safety Officer the successful tenderer intends appointing in accordance with the Occupational Health and Safety Act, Act No. 85 of 1993.
- Curriculum Vitae of all supervisory staff and safety personnel.

Further to the above, all tenderers shall be evaluated against the following Functionality Test in accordance with the following Evaluation Criteria:-

Threshold for pre-qualification for 8CE or higher is 80% (or minimum of 104 points) for the tenderer to be selected to participate in a closed tender process.

Threshold for pre-qualification for 6CE or 7CE is 70% (or minimum of 91 points) for the tenderer to be selected to participate in a closed tender process.

Threshold for pre-qualification for 4CE or 5CE is 50% (or minimum of 65 points) for the tenderer to be selected to participate in a closed tender process.

Threshold for pre-qualification for 2CE or 3CE is 30% (or minimum of 39 points) for the tenderer to be selected to participate in a closed tender process.
