**SUPPLY, DELIVERY AND INSTALLATION OF NEW JERSEY TYPE CONCRETE CRASH BARRIERS OR EQUIVALENT FOR THE MUNICIPAL MARKET**

Tenders are hereby invited from suitably qualified and experienced Tenderers for the Supply, Delivery and Installation of approximately 200 reinforced 40mPa New Jersey Type Concrete Crash Barriers. **Only Contractors who have a CIDB Grading of 2CE or higher will be eligible to tender.**

Tender documents shall be available from the Supply Chain Management Offices, 5<sup>th</sup> Floor, A. S. Chetty Building, 333 Church Street, Pietermaritzburg, from **14h30 on Friday, 9 December 2016**. A non- refundable tender fee in the amount **R180.12** per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Site Inspection Meeting for the above contracts will be held at **10h00 prompt on Thursday, 15 December 2016, at the Municipal Market, C B Downes Road, Mkondeni, Pietermaritzburg, 3201.** *Only one Site Inspection meeting will be held. Tenderers arriving at the meeting after the stipulated starting time will be disqualified. An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. Tenderers must present their tender document at the meeting failing which the Tenderer shall be disqualified. Only one (1) Representative per Company or Joint Venture or Consortium will be allowed to attend the above meeting.*

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 21 of 16/17**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00 on Thursday, 22 December 2016**, when they will be opened in public. Only tenders placed in the tender box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

**Tender Validity period:** Three (3) months commencing from the closing date of the tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
