The Msunduzi Municipality is currently in the process of implementing the Rapid Public Transportation Network Project and wishes to engage the industry on compensation as required by the National Land Transportation Act No. 05 of 2000. To this end, tenders are hereby invited from suitably qualified and experienced Service Providers for the above works.

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 43 of 16/17**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00 on Tuesday, 2 May 2017**, when they will be opened in public. Only tenders placed in the tender box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

**Tender Validity period:** Three (3) months commencing from the closing date of the tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and **Stage Two: 80/20** Preference Point System in accordance with the Preferential Procurement Regulations, 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
