Tenderers shall be required to meet at 10h30 prompt outside the Northway Mall Spar situated at the corner of Ottos Bluff Road and Old Greytown Road, Pietermaritzburg and thereafter travel in convoy to site.*** Only one Tender Briefing Meeting will be held. An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***Tenderers who do not attend the above meeting will not be considered.***

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 45 of 11/12**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00 on Thursday, 15 March 2012**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity period:** Three (3) months commencing from the closing date of the tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
